RELEASE OF LIABILITY - READ BEFORE SIGNING

You and on behalf of you heirs, assigns, personal representatives, and next of kin agree to HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS the Northport Church of God Bass Club, any of its representatives, officers, or board of directors, sponsoring agents, sponsors, advertisers, or other participants, with respect to ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSONAL PROPERTY, including but not limited to court cost and attorney fees, suffered or incurred while attending any club sponsored function.

You also agree to abide by the rules and by-laws set forth by the Northport Church of God Bass Club.
